Derbyniwyd cofnodion cyfarfod 23 Chwefror 2017 fel rhai cywir. *The minutes of meeting held 23 February were received as a correct record.*

Ar gychwyn y cyfarfod arwyddodd pawb oedd yn bresennol y “datganiad derbyn swydd” ac atgoffwyd pawb o’r Côd Ymddygiad, gan nodi y byddai hyfforddiant ar y cyd i Gynghorau Cymuned yr ardal yn Medi/Hydref 2017. *At the beginning of the meeting all present signed the “declaration of acceptance of office” and all were reminded of the Code of Conduct, the Clerk also informed all that there would be training on the Code for the area Community Councils in the Autumn.*

### **Materion yn codi/Matters arising.**

1. **Japaneese Knott Weed:** Roedd y Clerc wedi cysylltu efo Iestyn yn Cyfoeth Naturiol Cymru, a cafwyd addewid o drin y knotweed yn yr Hydref. *Clerk had contacted Iestyn at Natural Resources Wales and they will treat the knotweed in the Autumn.*
2. **Dwr Maescamddwr:** Clerc wedi cysylltu efo’r Cyngor Sir/ Clerk has contacted County Council.
3. **Golau Ystrad Meurig Lights:** Derbyniwyd e-bost oddi wrth Simon Bray, Cyngor Sir yn nodi bod angen gosod “uned” newydd ar y safle, ac y byddai hyn yn cael ei wneud o fewn yr wythnosau nesaf. *Clerk had received an email from Simon Bray, County Council noting of the need to place a new unit at the site, this will be done in the next few weeks.*
4. **Sgwar Tynygraig Square:** roedd y Clerc wedi cysylltu gyda’r Cyngor Sir a nodwyd bod tir Ty Mawr wedi ei gofrestru efo’r Ty a hynny ers dros 30 mlynedd. *The Clerk had contacted the County Council and the land opposite to Ty Mawr has been registered with the house for over 30 years.*
5. Cytunwyd bod y Clerc yn ysgrifennu at Mr Geraint Jones i ddiolch iddo am ei wasanaeth i’r Cyngor Cymuned am 20.5 mlynedd. *It was agreed that the Clerk wrote to Mr Geraint Jones to thank him for his services to the Community Council for 20.5 years.*

2. **Archwiliad Blynyddol 2016-2017:** cadarnhaodd y Clerc bod y cyfrifion wedi ei archwilio efo T. Jones yn fewnol a D Morgan yn allanol, erbyn hyn mae’r archwiliad yn orffenedig ac yn barod i’w cyflwyno i’r Archwiliwyr allanol. Cadarnhawyd bod adrannau 1 a 2 yn orffenedig a’i bod

yn cael ei cyflwyno i'r Archwilwyr erbyn 3 Mehefin 2017. Roedd pawb a oedd yn bresennol yn gytun.

**Annual Audit 2016-2017:** Clerk confirmed that the accounts had been audited internally by T Jones and externally by D Morgan and that the audit is now complete and ready to present to External Audit. It was confirmed that parts 1 and 2 were complete and to be presented for Audit by 3 June 2017. All present agreed.

4. Derbyniwyd llythron diolch oddi wrth Eisteddfod Swyddffynnon, Capel MC Swyddffynnon ac Ysbyty Bronglais am ein rhoddion ariannol. *Thank you letters were received from Swyddffynnon Eisteddfod and Swyddffynnon MC Chapel and Bronglais Hospital for our donations.*
5. **Un Llais Cymru/One Voice Wales:** Derbyniwyd llythyr yn cadarnhau ein aelodaeth am 2017-2017. *A letter was received confirming our membership for 2017-2018.*
6. Derbyniwyd gwybodaeth am gymorthfeydd Mark Williams ac Eluned Morgan. *Information was received with regards to surgeries with Mark Williams and Eluned Morgan.*
7. Arolwyd o Etholaethau Seneddol yng Nghymru – cyfnod yr ail ymgynghoriad yn rhedeg rhwng 28/2 a 27/3. Review of Parliamentary Constituencies in Wales – secondary consultation period from 28/2 to 27/3.
8. **CSC Pwyllgor Rheoli Datblygu** – derbyniwyd agenda a phapurau cyfarfod 8 Mawrth a 12 Ebrill 2017. *CCC Development Control Committee – agenda and papers for the meeting 8 March and 12 April 2017 were received.*

13. Derbyniwyd llythyr gan Melanie Walters, Caradog Cottage parthed cyflymder traffig drwy pentref Tynygraig ynghyd a nifer o lythron yn cefnogi i gael arwyddion cyflymder drwy'r pentref. Cytunwyd fel Cyngor ein bod yn cefnogi hyn ac mi fydd y Clerc yn anfon yr ohebiaeth ynghyd a llythyr o gefnogaeth ymlaen i'r Cyngor Sir. *A letter was received from Melanie Walters, Caradog Cottage re: speed of Traffic through Tynygraig village together with a number of supporting letters. As a Community Council we agree to this, and all letters together with a supporting letter from the Community Council should be forwarded to the County Council.*
