### **Materion yn codi/Matters arising.**

1. **Golau Ystrad Meurig Lights:** Derbyniwyd epost oddi wrth Simon Bray, Cyngor Sir yn nodi bod angen gosod “uned” newydd ar y safle, ac y byddai hyn yn cael ei wneud o fewn yr wythnosau nesaf. *Clerk had received an email from Simon Bray, County Council noting of the need to place a new unit at the site, this will be done in the next few weeks.*
2. Cytunwyd bod y Clerc i gysylltu efo Ifan Davies i ofyn os byddai unrhyw symudiad i osod 40 milltir yr awr i bentref Tynygraig yn hytrach na 30.
